BDC's investment into LCW has transformed it into one of the region's most advanced clay product manufacturers. The modernised facility is equipped with cutting-edge technology and boasts an enhanced annual production capacity of 36 million bricks. This significant increase allows LCW to meet the rising demand for high-quality building materials in Botswana, particularly for essential projects such as schools and infrastructure, while also positioning the company to reclaim its market share and reinforce its leadership in the industry.

Ms Boitshwarelo Lebang-Kgetse, caretaker CEO of LCW, highlighted that the successful commissioning of the facility reflects meticulous planning and effort at every stage. The plant now features advanced automation in clay processing, precise moisture control, and energy-efficient kilns. "By introducing premium products, LCW is well-placed to secure lucrative government contracts and contribute to key infrastructure developments," she stated, emphasising the company's commitment to quality and competitive pricing in the face of growing urbanisation and infrastructure needs across Southern Africa.

His Lordship, Mayor Mosimanegape Dithebe, expressed deep pride in the milestone this marks for Lobatse and its surrounding areas. "The revival of Lobatse Clay Works is a significant step in the transformation of our town," he noted, stressing that the project serves as a cornerstone for socioeconomic development, creating much-needed employment and revitalising the local economy. He praised the government's support for projects aligned with the national Reset Agenda and commended BDC for its long-term vision and investment in Lobatse, which includes other significant initiatives like Delta Automotive Technologies and Milk Afric.

Established in 1992 as a private entity wholly owned by BDC, LCW has been instrumental in the nation's economic development through local manufacturing. However, operational challenges led to the suspension of activities in 2017, prompting a comprehensive review of LCW's business model to ensure sustainable profitability and competitiveness. The decision to embark on a turnaround strategy marked a pivotal moment in LCW's journey towards revitalisation, adopting efficient, cuttingedge technologies that promise superior product quality for the benefit of customers. Beyond the plant, this project will create 240 jobs at full operational capacity, generating steady income, renewed hope, and paving the way for economic recovery within the community.
